Introduction

Who they are / where they are based

Kolektivo is a decentralized autonomous organization (DAO) based in Curaçao, with a mission to empower local communities through regenerative practices and technologies. The name "Kolektivo" means "collective" in Papiamentu, the native language of the ABC islands, symbolizing their commitment to collaboration and community-driven solutions.

History

Founded amidst the pressing global challenges of climate change and socio-economic disparity, Kolektivo arose from a vision of creating a sustainable future where local communities have the tools and resources to thrive. Drawing on experiences from various Caribbean, South American, and African communities, Kolektivo aims to apply innovative technologies and system innovations for real-world impact.



Context

The world is facing significant socio-economic and environmental challenges, including resource depletion, climate change, and social inequality. Traditional economic models have often exacerbated these issues, leading to a call for more inclusive and sustainable approaches. - **Environmental Credits:** Initiatives to create and tokenize environmental credits, enabling local projects to benefit from global markets for carbon and

biodiversity credits.

- **Microgrants:** Streamlined processes for issuing microgrants to support local projects, enhancing resource allocation efficiency.

Why a DAO as Organizational Construct

Kolektivo operates as a DAO to leverage decentralized governance structures, ensuring transparency, inclusivity, and community involvement in decision-making. This model allows them to:

- Empower community members to participate actively in governance.
- Foster collaboration and collective ownership of projects.
- Enhance transparency in resource allocation and decision-making processes.

Implementation

Permissions

Kolektivo's DAO structure enables members to propose initiatives, vote on funding allocations, and engage in community governance. Permissions are granted based on community membership, ensuring that all stakeholders have a voice in shaping the organization's direction.

Governance & Decision-Making

Kolektivo employs a decentralized governance framework that encourages participation from all members. Decisions are made through community voting, where members can propose changes, projects, or funding allocations. This structure fosters a sense of ownership and accountability among participants.

Community & Participation

Community engagement is at the heart of Kolektivo's operations. Members participate through:

- Regular community meetings to discuss initiatives and gather feedback.
- Online platforms for collaboration, discussions, and voting.
- Workshops and training sessions to enhance skills and knowledge.

Legal Entity Form

Kolektivo operates as a registered non-profit organization in Curaçao, allowing them to pursue their mission while maintaining a focus on community benefits rather than profit generation. This legal structure supports their DAO model by ensuring compliance with local regulations while promoting transparency and accountability.

Technology & Tools

Kolektivo utilizes a range of technologies and tools to facilitate their operations:

- **Blockchain Technology:** For the development of community currencies and tracking environmental credits.

- **Measurement, Reporting, and Verification (MRV) Tools:** To ensure the legitimacy of their environmental initiatives and credits.

Impact & Outcomes

- Successful issuance of microgrants to over 50 local projects, enhancing community resilience.
